**AN ORDINANCE CLOSING A PORTION OF EAST LONDON CHURCH ROAD IN  
THE CITY OF LONDON LOCATED ON PROPERTY OWNED BY EAST LONDON  
UNITED BAPTIST CHURCH**

WHEREAS, the City Council of the City of London has been requested by the East London United Baptist Church to close a portion of the city street that is located in the Church's parking lot and the property owners in and abutting the portion of the street that is NOT being closed have given their notarized written consent to the closing of the portion of the street in the Church's parking lot;

And whereas the provisions of KRS 82.405 have been followed. The City Council has made Findings of Fact pursuant to KRS 82.405, these Findings having been reviewed and signed by the London City Council and incorporated herein as if each part was copied herein;

**BE IT ORDAINED BY THE CITY OF LONDON, KENTUCKY, AS FOLLOWS:**

That the portion of the roadway as described as the East London Church Road, being a City Street from a pin common to the Rebecca Smallwood property and the East London Church intersecting with the James and Peggy Brock property and all of the City Street in the East London Church property, to the East 4<sup>th</sup> Street, all being located in the City of London be and is hereby closed. A plat of the same is attached to this Ordinance as Exhibit A and is adopted as a part hereof.

This Ordinance shall become effective immediately upon publication and shall be recorded in the Office of the Laurel County Court Clerk.

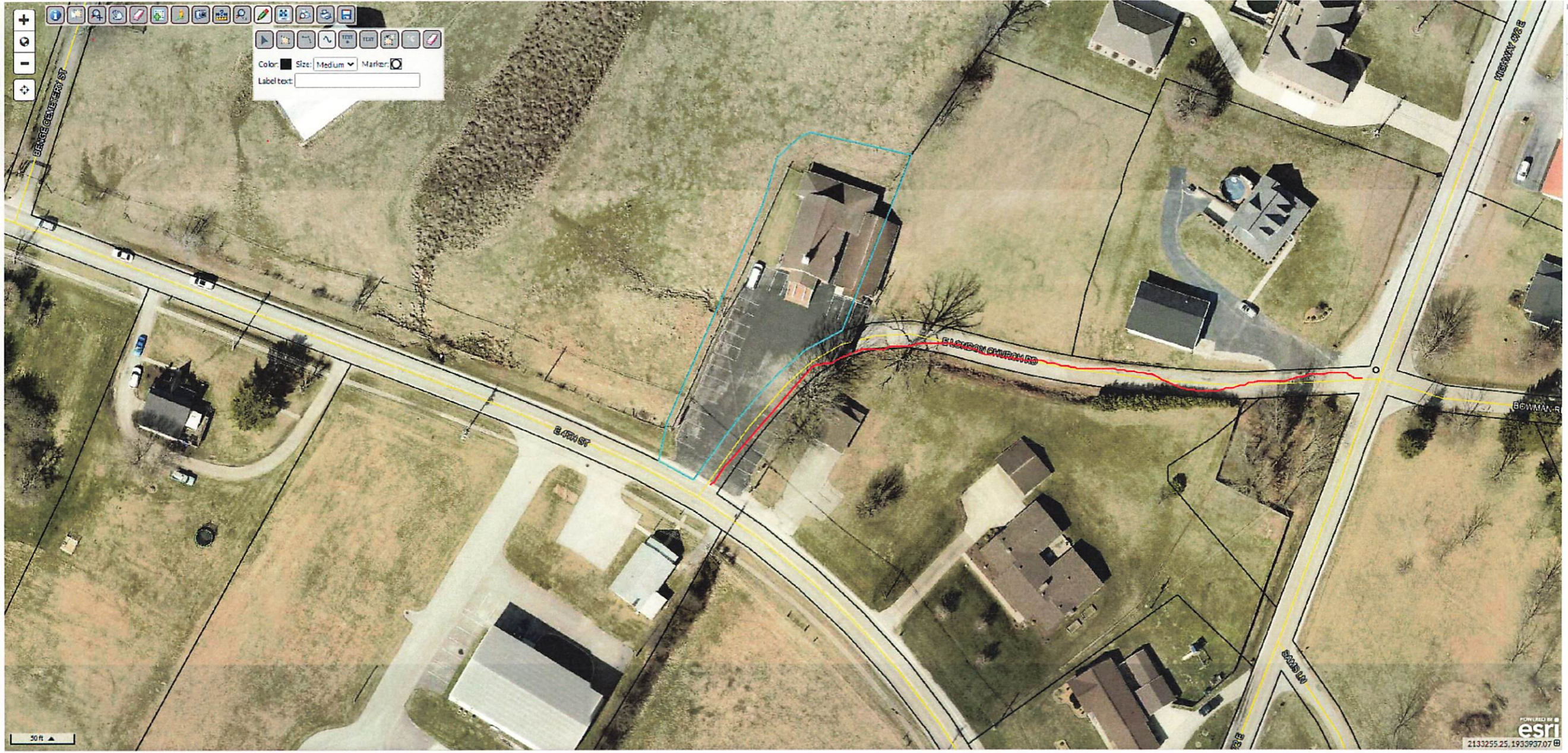

**CITY OF LONDON FINDINGS OF FACT  
REGARDING THE CLOSING OF A PORTION OF A PUBLIC STREET IN  
THE CITY OF LONDON KNOWN AS EAST LONDON CHURCH ROAD**

The City Council of the City of London has been requested to close a portion of a City Street known as the East London Church Road.

Pursuant to KRS 82.405, City Council makes the following Findings of Fact:

(1) The East London United Baptist Church has represented to this Council that the property owners abutting the portion of the East London Church Road have no objection to a portion of the East London Church Road being closed. The Church has requested that the portion of the East London Church Road that is located in the parking lot of the East London United Baptist Church should be closed.

(2) All of the above has been represented by East London United Baptist Church that all the property owners in or abutting this public street or road have given their written notarized statements that this public street or road be closed. A copy of their notarized consents are attached to this Findings of Fact made by the City Council.

(3) Following these Findings, the City Council has authorized the preparation, enactment and filing of an Ordinance closing the aforementioned public way.

(4) These Findings shall be attached to the Minutes of the City Council of the City of London.
