Application Instructions:

- Please fill out each section of both the state and local application.
- Fill out one application for each license.
- All documents required for a state license should accompany this license including but not limited to:
 - Proof of residency and citizenship
 - Current background check for all partners
 - Newspaper affidavit
 - Organizational papers of an LLC
 - Partnership or corporation
 - Current deed or lease of property to be licensed
 - KY sales tax and Federal tax numbers
 - Business Statement
- \$50 of the total application fee will be non-refundable. We will not accept cash or cards of any kind.
- An employee or owner who will be accountable for the sale of alcohol must present the application to the local ABC office in person and a notary will be supplied.
- A business that sells gasoline or does maintenance on motor vehicles must validate that they maintain a \$5,000 inventory of groceries on site.
- Applications will be accepted by appointment only. Please email abc@londonky.gov (preferred) or call to schedule.
- After receiving the application, the following City Offices will be contacted by the ABC to verify compliance with the Food Code, Building Code, Fire Code, Planning & Zoning Code, and City Tax payment verification.
- Sign-offs must be received from these departments before final application approval can be processed:
 - Laurel County Health Department
 - Kentucky Fire Marshal
 - City Building Inspector
 - City Planning & Zoning
 - City Clerk

- A. Inspections and searches of the licensed premise(s) for which this application applies.
- B. Confiscation of articles found on said licensed premise(s) which violate(s) any local Ordinance or state Statute; and
- C. Emergency and/or temporary closure of the licensed premise(s) if there is reasonable suspicion by the City or any agent thereof, that the public health, safety, morals, and welfare of the citizens are threatened due to multiple violations of any Ordinance or state Statute, including, but not limited to, laws/regulations regarding disturbance of the peace and public disorder, which the City, or any agent thereof, believes to have occurred during any one day period of operation of the licensed premise(s).
