APPLICATION FOR PERMIT FOR GOLF CART OR UTV

This application for a Permit is made pursuant to London City Ordinance No. 2024-05. By my signature hereon, I state that I have read said Ordinance in its entirety, which was provided to me by the Office of the London City Clerk. I understand that:

- I cannot operate my golf cart or UTV on US 25, US 192, the Hal Rogers Parkway or any other state or federally funded highway located in the City of London.
- I agree to maintain general liability insurance and proof of insurance for the golf cart or UTV at all times of operation on the city streets of London.
- I agree that at all times of operation on the city streets, the headlights, tail lights, turn signals, horn, brake lights, parking brake, seat belts for each designated seating position, one (1) reflex reflector on each side as far to the rear as practicable and one (1) red reflex reflector on the rear in the golf cart or UTV (with UTV, a working muffler) and an exterior mirror mounted on the driver's side and with an interior mirror or an exterior mirror mounted on the passenger's side will be maintained in working order. (KRS 189.281)
- I agree that I will not exceed the speed of 35 mph at any time.
- I agree that at all times of operation, seat belts will be used by the operator and all passengers.
- I agree that I will not knowingly allow a minor under that age of six (6) to operate my golf cart or UTV. (KRS 189.515)
- I agree that I will not knowingly allow a minor under the age of sixteen (16) years of age to operate my golf cart or UTV unless under direct parent supervision (but not in violation of the age restriction warning label affixed by the manufacturer as required by the federal UTV standards). (KRS 189.515)
- I agree to comply with all applicable traffic regulations.
