


A SUMMARY OF ORDINANCE NO. 942 ENTITLED  
"AN ORDINANCE REZONING NORTH LAUREL HIGH SCHOOL PROPERTY  
LOCATED ON THE DANIEL BOONE PARKWAY, LONDON, KENTUCKY AND  
OWNED BY THE LAUREL COUNTY BOARD OF EDUCATION."

This summary is prepared pursuant to KRS 83A 060 (4) as a correct summary of this Ordinance. The main points of this ordinance are that a public hearing was conducted by the London-Laurel County Zoning and Planning Commission on the 10<sup>th</sup> day of March, 1998, following a written request by the Zoning Commission that the property be rezoned. This property is located on and is particularly described in the full text of the ordinance. All of the requirements of KRS 100.211 have been met. The Zoning and Planning Commission recommended that this property be zoned from I-1 (Light Industrial) to C-2 (Commercial), and that the Zoning Map be amended to reflect this change. The ordinance as written accepts the Commission's recommendation and ordains that this property be rezoned from I-1 (Light Industrial) to C-2 (Commercial). There has been compliance with KRS Chapter 100.

AN ORDINANCE REZONING NORTH LAUREL HIGH SCHOOL PROPERTY  
LOCATED ON DANIEL BOONE PARKWAY, LONDON, KENTUCKY  
AND OWNED BY THE LAUREL COUNTY BOARD OF EDUCATION

BE IT ORDAINED BY THE CITY OF LONDON AS FOLLOWS:

A public hearing was conducted by the London-Laurel County Zoning and Planning Commission on the 10<sup>th</sup> day of March, 1998, concerning the rezoning of property owned by the following persons:

- (1) Laurel County Board of Education

North Laurel High School Property is located on the Daniel Boone Parkway, London, Kentucky, the zone change request was initiated by the London-Laurel County Planning Commission, in order that the zoning of the property more appropriately reflect the property's use. The Commission has requested that this property be rezoned from I-1 (Light Industrial Use) to C-2 (Commercial). It has been represented to the City Council of the City of London that all requirements of public notice have been met in keeping with KRS 100.211. The London-Laurel County Zoning and Planning Commission has made a recommendation of approval of this requested zone change and that the zoning map be amended to reflect these changes. It has also been represented to the City Council that all legal requirements have been met and that there has been compliance with all applicable provisions of KRS Chapter 100.


IT IS THEREFORE ORDAINED AS FOLLOWS:

(1) The North Laurel High School property located on the Daniel Boone Parkway in London, Kentucky owned by the Laurel County Board of Education be rezoned from I-1 (Light Industrial) to C-2 (Commercial) and that the zoning map reflect these zone changes. A description of this property is more particularly set out hereinbelow:

1. Being the same property acquired by the Laurel County Board of Education from Begley Lumber Company, Inc., dated September 20, 1990 of Record in DB 380, at page 417.

All references to Deed are from the Laurel County Court Clerk's Office.
