AN ORDINANCE AMENDING ORDINANCE NO. 2019-05 ENTITLED "AN ORDINANCE PROHIBITING THE SELLING OR VENDING OF GOODS FROM BOOTHS WITHIN THE CITY LIMITS OF LONDON, KENTUCKY, DURING THE DAYS OF THE WORLD CHICKEN FESTIVAL EXCEPT AS AUTHORIZED BY THE WORLD CHICKEN FESTIVAL, INC.

WHEREAS, the World Chicken Festival, Inc., has been authorized by the City of London, Kentucky, to operate the World Chicken Festival activities within the City of London, Kentucky, during certain days in September of each year, and,

WHEREAS, the Chicken Festival activities are planned by the World Chicken Festival, Inc., and are authorized and monitored by the same, and,


WHEREAS, certain streets are designated by both the City of London and the World Chicken Festival, Inc., for the operation of certain booths and since the beginning of the Chicken Festival its activities have grown and individuals and groups who are authorized by the World Chicken Festival, Inc., have begun setting up booths and selling goods outside the streets and other areas designated for the festival activities to take place. This Ordinance is considered to be in the interest of the public health and safety of the individuals of the citizens of London, Kentucky,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LONDON, as follows:


1. It shall be unlawful for any person to operate a stand or booth open to the public for the selling of foods, drinks, or goods of any nature on any city sidewalk, city street, or private property outside the area designated by the City of London for the World Chicken Festival activities.
2. This Ordinance shall not apply to the renting of parking spaces by individuals or groups.
3. Any violation of this Ordinance shall result in a fine of not less than One Hundred Dollars (\$100.00). Each day of violation shall constitute a separate offense. Upon written direction of the City Police of the City of London, the operator of such a stand or booth shall immediately cease and desist that business and remove their booth or stand. If such booth or stand is not removed within eight (8) hours of such written direction of the London City Police, the London City Police shall cause the removal of the booth or stand.

If any section, clause, sentence, or phrase of the Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall not affect the validity of the Ordinance as a whole, or any portion thereof, other than the section so declared to be unconstitutional or invalid.

This Ordinance shall be effective immediately upon publication in accordance with the applicable provisions of Kentucky law. Any Ordinances or part of Ordinances in conflict herewith are hereby repealed.
